

## **“Free Ride to Keeneland or Cincinnati Reds “Sweepstakes**

### **SWEEPSTAKES RULES AND REGULATIONS**

**1. NO PURCHASE, CONTRIBUTION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE CHANCES OF WINNING. THIS SWEEPSTAKES IS SET UP AS A NON-GAMBLING PROMOTION.**

From all of the eligible entries received, the winners will be determined based on a random drawing as outlined in Paragraph 7 of these rules.

**2. ELIGIBILITY:** The Sweepstakes is open to contestants who follow us on Facebook at the time of the drawing, which will be 04-01-19. The Sweepstakes is only open to legal residents of the United States in the sponsor’s (A Motortoys Limousine Service Inc (Motortoys)) operating area of Greater Cincinnati. This offer is void elsewhere. **6. SELECTION OF WINNERS:** One (1) winner will be randomly chosen from Motortoys list of Facebook followers and notified by email on 04-02-19. All potential winning entries, as well as any alternates, will be drawn by the Sponsor, whose decisions shall be final and binding. If an entrant changes its email address it is the sole responsibility of entrant to notify the Sponsor during the Sweepstakes Period.
