



Wheel of Fortune Contest Rule and Regulations as of 08-15-19

Who Can Enter

1. To enter, contestants must be legal age (18 years old).
2. Employees (including, without limitation, part-time or temporary employees) of the Motortoys, contest sponsors the immediate family and other household members (i.e., spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners and siblings) of each of the above are NOT eligible to enter and/or to win the Contest.

Entry

1. No purchase is necessary to enter or win. Contestants may only enter once per 24 hours, unless specified otherwise. Contestants can only win once every 30 days.
2. Motortoys is not responsible for any entries, internet connections and/or telephone calls that are misdirected, lost, stolen, disconnected, not received, or are illegible. Motortoys is not responsible for any printing errors. All entries become the property of Motortoys and will not be acknowledged or returned.
3. One or more contests may be announced from time to time. Motortoys may run more than one contest simultaneously, but entries will only be solicited for one contest at a time.
4. Depending on the contest, Motortoys will designate the required method of entry. The following apply to the applicable entry method designated:
 - a. For internet based entries, use of robotic, automatic, programmed or similar entry modes is prohibited and will be void. In case of an identity dispute, the registered user of the account on the date of entry will be the recognized user.
 - b. If a name is announced on-line as a potential winner who is required to call-in to win, only the actual person who entered can win and must be the person who calls in. Persons having the same name will be disqualified if not the actual entrant.
5. Wheel of Fortune entries will only be accepted on-line. All comments/entries to be valid must be associated with a Facebook user who has LIKE/FOLLOW the Motortoys Facebook Page.

Prize(s)

All winners are required to sign a Rental Agreement relieving Motortoys, its parents, subsidiaries, officers, directors, members, managers, employees, agents and contest sponsors from any and all liability with respect to the contestant's participation in the contest and the receipt and/or use of the prize. Any person who refuses to sign the Release and/or provide an ID forfeits the contest prize.
